

## **Forest Grove Farmers Market Community Booth Information**

Thank you for your interest in the F.G.F.M. We are pleased you will be attending the Market. The Market runs Wednesdays from 4pm-8pm May 12, 2009 through October 13, 2010. The Market is located in Downtown Forest Grove on Main Street between 21<sup>st</sup> Avenue and Pacific Avenue.

The Community Booth is available one time free of charge to non-profits and community groups throughout the year. Each additional time the booth is \$20/week. Additional weeks depend on availability. You are not allowed to sell anything at the booth unless you've received prior approval from the Market Manager.

We ask that the community partners provide a tent, table and chairs for their Market booth. The booth space allotted is 10' x 10'. You are required to have a tent. Please let Market Manager know at least 2 weeks prior to scheduled date if you need a tent. If one is available, it will be provided for \$10.

Set up is anytime after 2pm – no later than 3:40pm. Vehicles CANNOT enter Market area after 3:40 pm. We ask that you are **ready to go at 3:50pm**. You are **required to stay until the end** of the Market at 8 pm. Please enter the Market area from 21<sup>st</sup> Avenue. Off-load all supplies, move your vehicle and then return to set up.

When you arrive at the Market please look for the Market Manager or staff to find your assigned spot. Parking can be found in the public lots on 21<sup>st</sup> Avenue west of Main Street and 19<sup>th</sup> Avenue between Ash and Council (2 blocks SE of the Market) and on College Way between University Avenue and Pacific Avenue.

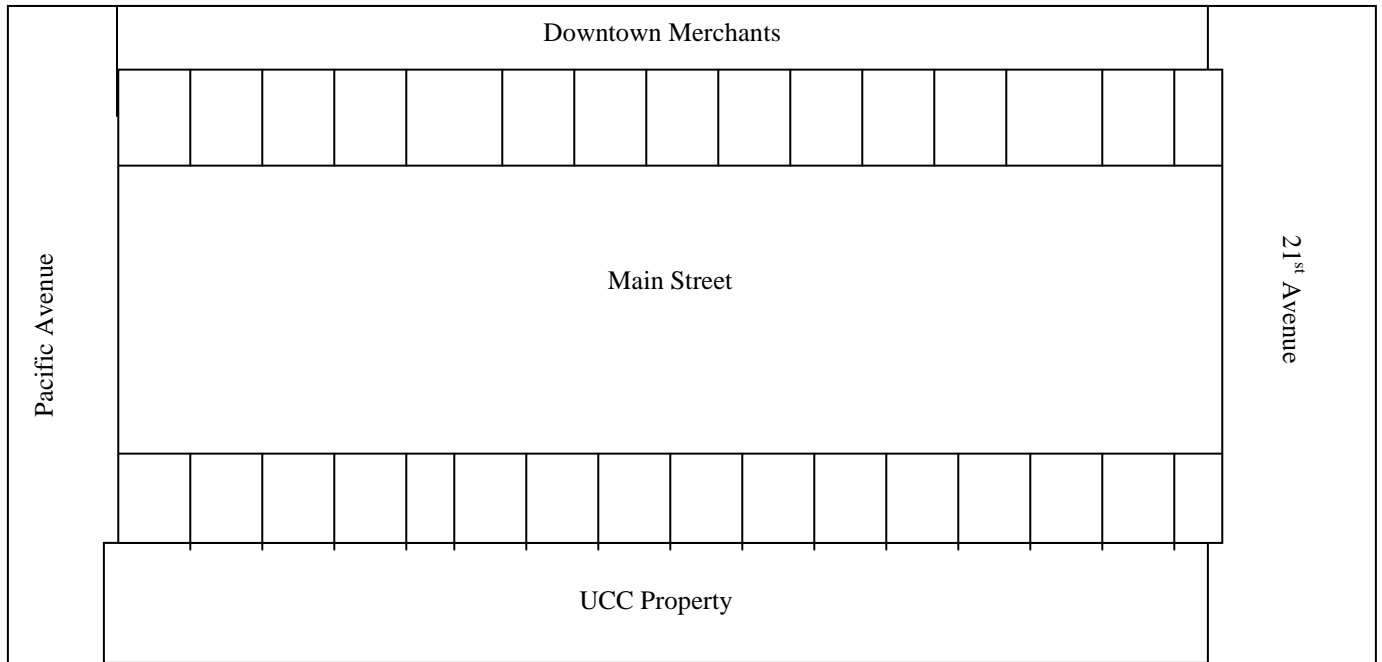
